IMPORTANT RENTAL INFORMATION AND CONDITIONS

This application is **not complete** unless ALL areas are **initialed** and it is **signed & dated** on the bottom

RENTAL PERIOD: A four day minimum rental. Unless prior approval, pickup time is between 1:00 and 4:00 PM and return time is prior to 11:00 AM **SHARP!** The renter will be charged \$25. per hour for a vehicle returned late and 1-1/2 the daily rental rate for each day the vehicle is late. **REMEMBER** – Other people may be waiting for the vehicle. Please contact our office if you are going to be delayed. No vehicle may be picked up or returned on Saturday or Sunday.

DOWN PAYMENT _____ (initials) A down payment of \$250 is required to guarantee a reservation on all RV rentals.

CANCELLATION POLICY _____ (initials) From the date of the reservation to 30 days prior to the pick-up date on RV rentals, we will refund the down payment less \$50 cancellation fee. **NO REFUND** of your down payment will be given if cancellation is less than 30 days prior to departure on RV rentals.

SECURITY DEPOSIT: _____ (initials) A \$500 security deposit with a major credit OR \$1,000 cash is due at the **TIME OF PICK-UP**. Refundable within 5 business days of return providing the vehicle is returned in the same condition as when it went out. If the charges exceed your security deposit, you will be responsible for paying the excess balance owed. Refund or extra charges will be detailed on the adjusted rental agreement that will be mailed to you at the close of the contract.

CLEANING DEPOSIT: _____ (initials) A \$69 cleaning deposit is required on all rentals. Refundable within 5 business days of return providing the vehicle is as clean inside as when it was received. NO SMOKING is allowed and unit should be returned odor free from smoke (including campfire smell).

INSURANCE COVERAGE _____ (initials) The vehicle must have full coverage insurance before it leaves our lot. You have a choice of bringing in a binder listing us as additional insured through your own personal insurance, or, if your insurance will not extend to the rental vehicle, you will be required to purchase full coverage insurance directly through MBA Insurance. The rate is \$15-\$25 per day (to be purchased at www.mbachoice.com using VISA or MasterCard + \$10 processing fee).

OTHER IMPORTANT INFORMATION _____ (initials) **A)** The person/persons named on the **RENTAL RESERVATION FORM** must have a valid major credit card, and is the **only person/people** authorized to sign the rental agreement and drive the vehicle off our lot; **B)** No refund will be issued if the vehicle is returned prior to the scheduled return date; **C)** The rental vehicle is not permitted into Mexico; **D)** SMOKING, open flames such as candles or incense are prohibited and use of Awning is strictly prohibited; **E) PETS OR TOWING OF ANY TYPE IS PROHIBITED** unless approved prior to pick up and additional fee is paid (limited availability; specific units only, service animals OK); **F)** All departures and returns are at SHR Leasing LLC, 1608 Industrial Road, Nampa, ID unless prior arrangements have been made and paid for; **G)** All authorized drivers must have a clean driving record, be at least 25 years old, **be present at the time of departure** and have their **valid picture** driver's license; **H)** All rental vehicles are subject to sale. We cannot guarantee a specific vehicle will be available. You will be **guaranteed** a vehicle of our choosing which most closely matches what you reserved per availability. However, we can guarantee the same rate and we will make every effort to do so. We will notify you if there are any changes in your reservation; **I)** If involved in an accident you must notify dealer within 24 hours. A full written police accident report must be submitted to our management upon your return. Failure to comply will result in the forfeiture of your security deposit. **J)** Gasoline tanks are released full and must be returned full. If not, the renter will be charged the cost of gas at \$7.50 per gallon.

You have read and agree with all of the conditions on this RENTAL RESERVATION and all information you have given us is true and correct. You understand that we may perform a credit investigation on you and a DMV check on all drivers; you hereby authorize us to receive information on your credit and driving record from others. The credit card listed above is issued in your name with the billing address the same as listed above. You also authorize us to charge your credit card listed above for the down payment amount shown. You have read and understand that SHR Leasing LLC may retain all or part of that down payment in the event of cancellation according to the cancellation policy stated above.
